## Emergency planning and contingency planning

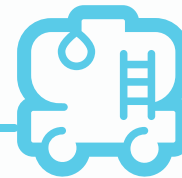

### Don't rely on your water wholesaler

If there is a problem with the water supply, water wholesalers have a limited capacity to provide emergency water and have to give priority to vulnerable sites, like hospitals. If they can help, it's likely to be just water to drink.

#### ● Emergency water supplies

This can be in response to an unplanned interruption, or a pre-planned event.

#### ● Bulk water delivery

Deliveries of 10,000 to 30,000 litres of water to fill reservoirs, storage tanks, or to inject directly into your network.

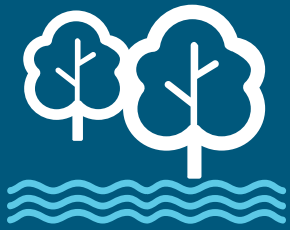
#### ● Water storage

Static tanks with a capacity of 1,100 litres to 10,000 litres connected to your supply, or as standalone facilities, with quality-assured water and refilled and maintained as required.

#### ● Bottled water

This can be supplied in large quantities and delivered wherever needed, on-site or for off-site events.

## Alternative water supplies



**An on-site, or near-site, water supply to to your premises can reduce overall operating costs, with the benefit of a lower environmental impact.**

Improved technology now means taking water from an alternative supply, treating it within regulations so it's fit for purpose up to drinking standards, is a viable option.

Water from rivers, and taken from aquifers underground via a borehole, cuts out the cost and environmental impact associated with the lengthy normal mains supply network.

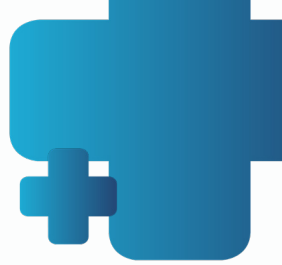
